RELEASE OF LIABILITY

READ CAREFULLY - THIS AFFECTS YOUR LEGAL RIGHTS

Important: A form must be filled for each Minor age 14/15.

In exchange for participation in the activity of Minor age 14/15 swimming organized by Woodlawn Homeowners Association ("Woodlawn HOA"), of 9621 Erinsbrook Drive, Raleigh, North Carolina, 27617 and/or use of the property, facilities and services of Woodlawn HOA, I agree that myself and my child, to the following:

1. I agree that my child will observe and obey all posted rules and warnings, and further agree to follow any oral instructions or directions given by Woodlawn HOA, or the employees, representatives or agents of Woodlawn HOA. If asked to leave the pool area, my child must leave for the day, unless escorted back with a parent. A second time may lead to cancellation of this agreement.
2. I recognize that there are certain inherent risks associated with the above described activity and I assume full responsibility for injury to my child, and further release and discharge Woodlawn HOA for injury, loss or damage, whether caused by the fault of my child, Woodlawn HOA or other third parties.
3. I agree to indemnify and defend Woodlawn HOA against all claims, causes of action, damages, judgments, costs or expenses, including attorney fees and other litigation costs, which may in any way arise from my child's use of, or presence upon the facilities of Woodlawn HOA.
4. I agree to pay for all damages to the facilities of Woodlawn HOA caused by my child's negligent, reckless, or willful actions.
5. I realize this is a non-guarded pool facility and swim at your own risk is clearly posted and published at the site. In the event of a medical emergency 911 will be called if attendant staff is on duty at the time of any incident. Additionally every effort will be made to contact guardians of said minor.
6. Any legal or equitable claim that may arise from participation in the above shall be resolved under North Carolina law.
7. I agree that the no underage guests will be allowed to accompany my child to the pool, even if they are residents of the Woodlawn community. I further agree that my Woodlawn HOA dues will be kept current, or my child's permission will be revoked.
8. If any minor from your household is caught using the pool without a parent or guardian present, or this signed document, it is possible that all pool privileges will be revoked for the entire household for the entire season.
